I. CALL TO ORDER of the '92-'93 Senate at 12:50 after luncheon.

II. MINUTES of the April 19, 1993 meeting were approved as corrected.

III. Suspension of the '92-'93 Senate to install the '93-'94 Senate

IV. CALL TO ORDER OF THE '93-'94 SENATE

A. The elections for At Large Senators and representatives for the Peer and Advisory Committees were announced.

B. The slate for the officers for next year's senate was presented with the following names in nomination:

Parliamentarian: Ray Mc Neil

Secretary: Don Kelm

Budget Chair: Mark Stavsky Curriculum Chair: Linda Olasov

Nominations were then solicted from the floor for the remaining offices. After an embarrassing period of reluctance by anyone to have their name placed in nomination, cajolery and coercion carried the day. The following individuals were nominated:

Vice-President: Tom Cate Benefits Chair: Chuck Frank

No amount of guilt-laden silence could induce anyone to be placed in nomination for President and Professional Concerns Chair. Motion to close nominations (Cate/Miller) was carried. Motion was made to adopt the slate of candidates by unamimous acclamation (Scott/Rosenthal) and passed. And so was an incomplete slate of Executive Officers of the '93+'94 nominated and swept into office on a wave of apathy. Mike Thomson, outgoing president of Faculty Senate, expressed his thanks and relief and is well deserving of many thanks for a job done with excellence, panache, and verve.

- V. Since there was no further business for the new Senate, the new Senate was adjourned and the '92-'93 Senate was re-convened at 1:18 pm.
- VI. There were no deletions to the agenda for the '92-'93 Senate'.

A. FACULTY BENEFITS: Cheryl McKenzie, Chair

1. re: ERP: an oral agreement would appear to be in process. The procedure is to be self-funded w/ all salary savings returning to Office of the Provost. A written statement will be forthcoming. Don't rush out to buy that condo in New Mexico.

2. <u>Faculty Senate Award</u> was given to <u>Fadi Nahhas</u>, graduate from the College of Business.

- a. The description of the nature of the Faculty Seante Award was present and passed unaminously after changing the last word in the last sentence from quantity." to "quality."
- 3. The Faculty Development Brochure is to be finished this summer.
- 4. A memorandum from the Acting Provost Easton was presented which recommended ...
 - a. <u>increasing the Summer Fellowship stipend</u> from \$3K to \$3.960 per fellowship
 - b. increasing the number of fellowships to be funded from 12 to 14
 - c. increasing amount for funding project grants from \$25K to \$30K and requested a written response to the above by May 25. A final draft would then be submitted to (the new) Provost Gaston for consideration. Final recommendations would be copied to the Chair of Faculty Benefits.
- B. BUDGET AND COMMONWEALTH AFFAIRS: Sudesh Duggal, Chair
 - 1. The Subventions Policy document was submitted for a vote Motion to approve (Jacobsen/Kempton) passed with one abstention
- C. UNIVERSITY CURRICULUM: Linda Olasov, Chair
 - 1. Race/Gender offerings (SOC 110, 210, 250; HIST 105; Women's Studies 150. These have been received by UCC but not voted on. Over the summer these course shall be checked against criteria. In the Fall of '93 these courses shall be formally dealt with by the General Studies sub-committee and the UCC for final vote which shall then be brought before the Senate. The intent is to do so before the October deadline for the '94-'95 catalog.
 - 2. The revised UCC manual has been distributed.
 - 3. RTF 250 which is already a course was <u>submitted for General Studies</u> standing. There was considerable, emotional, reasoned, heated, loquacious, and voluable discussion on this course mostly centering on the issues of 1) keeping liberal studies and professional studies as separate entities and 2) popular culture issues versus formal, classical learning. <u>Question was called and the course passed</u> by the required 2/3 majority.
 - 4. Statement of Concentration was submitted for consideration and vote, the above issue had been so exhaustingly--not to say exhaustively--discussed that many senators left. Without a quorum no further business could be conducted and the '92-'93 Senate was adjourned, not having finished the business of the year.
