

- I. President Dan Alford called the meeting to order.
- II. Minutes of the previous meeting were corrected as follows: under Committee Reports, the By-Laws Committee Chair Pat Mullins stated "following or an eligible member an addition of: as defined in Article 4, Section 3 of the Staff Congress Constitution for each vacany....". There being no other corrections or additions Pat Mullins made a motion to approve, seconded by Dolores Thelen. Motion passed.

A correction was made on the Agenda changing the date of the meeting to be August 7 instead of August 9. (Minutes of previous meeting to be approved.)

## III. President's Report - Dan Alford

- a) Dan referred to the correspondence attached to the agenda regarding the recommendation from Staff Congress to fill the Staff Representative slot for University Parking Appeals Committee with Mark Dryden. Letter attached dated August 30, 1984 listed Terry Andrews as Staff Representative in error as Danny Bayes replaced her on last year's committee.
- b) There is a vacancy in the Physical Plant due to the resignation of Carol Guthier as representative. The executive committee decided it would be inappropriate to replace her at this time. This action taken due to the Congress only having one more meeting before the next election.
- c) The Congress secretary's office has been moved from Fine Arts since the space is needed by Fine Arts and will no longer be available for Congress use. It was requested of the Faculty Senate if the secretary could use their office as she serves both the Senate and Congress. A formal request has been made for permanent office space for the Congress secretary. Faculty Senate has done the same, and we should be receiving some response on that request.

The biographical data of Dennis Taulbee, Director of University Budget and Planning was given by President Dan Alford who presented him to those in attendance.


After a lengthy informative speech, Mr. Taulbee answered questions from the audience. He also shared copies of the 1984 General Assembly Final Enacted Budget Memorandum for 1984-86, this information to be given to the staff members regarding the 2% annual raise. Namely:

### ARTICLE III. BUDGET INTENT STATEMENTS:

The General Assembly budget directs that funds for the total annual increment allowance for university personnel shall be limited to not more than 2% in Fiscal Year 1984-85 and not more than 3% in 1985-86......

#### REPORT TO STAFF CONGRESS

AUGUST 9, 1984

The Constitution & By-Laws Committee recommends the following revision to the By-Laws:

Article VI - Standing Committees of the Staff Congress

Section 2 - Appointment

a) Each year at the November meeting, or when a vacancy occurs, the Executive Council, described in Section 3 of this Article, shall report to the Staff Congress existing vacancies in standing committee memberships and shall submit to the Staff Congress the name of a Representative or an eligible staff member for each vacnacy existing or known to have occurred.
