MINUTES

MAY 12, 1988

The May 12 meeting was called to order by President Don McKenzie at 1:12 p.m. A quorum was present.

I. President McKenzie asked for any additions, deletions, or corrections to the April 14, 1988 Minutes. There was one correction under "New Business". The first line should read-Mary Wilson., not Marjorie Scheller. There were no other additions, deletions, or corrections therefore Rocke Saccone moved that the minutes be accepted. Ron Rieger seconded the motion.

II. GUEST:

Don McKenzie introduced James R. Thomas, field representive for Kentucky Public Employees Deferred Compensation System, who was on campus to speak to various groups about deferred compensation plans authorized under sections 457 & 401(k) of the U.S. Irs Code, and section 18A.230-18A275 of the Kentucky Revised Statutes.

Mr. Thomas started out by explaining that the now existing retirement savings plan monies contributed by the employee is deducted after taxes from ones paycheck. By using the deferred system the employee can have his or her retirement savings deducted before taxes, adding the amount of money that would have gone to taxes to the retirement deduction therefore enlarging ones contribution to their retirement fund, reducing ones taxable income, and leaving ones spendable income the same.

He then went on to explain that if the employee should go with the deferred system he or she could choose from plan 1 or plan 2.

Plan 1 has been offered since 1975 to Kentucky state employees, and is authorized by section 457 of the U.S. IRS Code. It features up to 25% of ones income deferrable with a maximum of \$7500 annually. Deferrals remain the property of the employer until they are paid out. This plan carries a stipulation for unforeseeable emergency withdrawals. It also has a "catch up" clause. The benefit commencement date must be elected upon termination of employment and no rollovers are permitted.

Plan II is a new plan authorized under section 401[k] of the U.S. IRS Code. This plan offers the employee 20% of income with a maximum deferral of \$7313 annually. Deferrals and earnings are put into a trust in the employees name immediately. The plan carries a stipulation for financial hardship withdrawals and offers a special 5 year forward income averaging on lump-sum withdrawals after age 59 1/2. Benefit commencement date may be elected anytime after termination of employment. Rollovers to other qualified plans or IRA's are permitted under certain circumstances.

In Plan I benefits begin on April 1 of the calendar year following the attainment of age 70 1/2. The employee may elect an earlier payment of benefits, but this must be done before the 61st day after the last day of employment with the university.

Plan II states an employee automatically receives benefits at the age of 65 (if retires from the same employer) but no later than April 1 of the calendar year following the age of 70 1/2. The employee may at anytime elect to select a benefit payment date.

Mr. Thomas went on to explain several options one has of investing the monies put into the plan, until paid out as benefits. In closing Mr. Thomas asked that everyone think about the information he had just given, and if they wanted to talk with him more to fill out the card in the booklet he had handed out, and mail it to the home office. Once he received the card he would get in touch with each person at his or her home.

A few questions were asked of Mr. Thomas. The first question was, "Is the amount contributed to the Kentucky Employee Retirement System (KERS) deducted from the amount one can deposit each year with this system?" Mr. Thomas answered, "Yes." He went on to say that just through the rest of 1988 an employee can contribute to both plans.

Another question was "Should a person leave their employment do they have to option to leave their money in the plan they selected?" Mr. Thomas answered, "Yes, and it will continue to earn interest."

Someone else wanted to know if there was a specific time for enrollment into this system? He answered that there was open enrollment.

The last question asked of Mr. Thomas was, "What if a spouse has a 401(k) also, is the maximum just \$7313?" He answered, "No, each persons salary is his or her own, each person is treated individually."

This concluded the quest speakers talk, the floor was returned the floor to President McKenzie.
