Nancy Martin called the meeting to order at $3: 05$ p.m. She gave background on the process of electing the Provost Search Committee. President Boothe had initially asked Faculty Senate to elect the four faculty from his list of nominees. Faculty Senate agreed to accept his nominees, but opened the nominations to all faculty. Faculty Senate is holding the election rather than the whole faculty at the request of President Boothe.

In terms of eligibility of candidates, the candidates are defined as faculty by definition in the Faculty Handbook. Chairs of departments are included in this category.

Nancy turned the chair over to Ted Weiss because she was a candidate for the committee. Ted Weiss reported that the executive committee recommended the election be held in two stages with an initial ballot held to cut the number of candidates to 10 and a final ballot to elect the 4. Each ballot may be for 4 candidates or fewer. Tom Rambo moved we follow that procedure and the motion passed by acclamation.

Dennis $0^{\prime}$ Keefe, Macel Wheeler and Andrea Gauthier were appointed to collect and count the ballots. The 10 candidates from the first ballot were:
