All the Books & Accounts kept by and between [between] us shall be Closed. except the outstanding debts & credits represented by a duplicate statement Marked X. Y. Z. And hereto attached showing the debts to amount to \$1.467.97/100 Dollars & the afsetts [assets] to amount to about 2.831 16/100 Dollars.

David Sinton having fully paid the amt. [amount] of his purchase. And Wm [William] Reser having made a parcial [partial] payment in Cash for his purchase. Exicuted [Executed] to us three promasory [promissory] Notes for the balance [balance] dated Oct 1/55. [October 1, 1855] the first payable 10 months. the second 12 months and the third 14 months after date. each for the sum of \$3.888 89/100 Dollars. The 2nd Note Due 12 months after date We have sold to Dr G G Lowry the 1st and 3rd Notes is still on hands. Which together With Grover & Madisons Acceptance of E. M. &. H. Bruces Draft dated Terre Haute Nov 1/55 [November 1, 1855] payable six months after date for \$375 57/100 Dollars is this day convayed [conveyed] by our endorcement [endorsement]

upon said Notes to H. Bruce [Henry Bruce] in part payment of a ballance [balance] due him by us under the style of our firm (E M & H Bruce)

and for our half of the remaining balance [balance] due him the said E. M. Bruce. [Eli M. Bruce] has exicuted [executed] his Note dated Jan 1/56. [January 1, 1856] for the sum of \$830. payable one day after date with 12 pr cent [percent] interest from date.

This settlement also embraces \$1.000 Cash advanced Nov 15/55. [November 15, 1855] and \$500. Cash advanced Dec 19/55. [December 19, 1855] by H. Bruce [Henry Bruce] for our joint benefit. to our present firm Under the Style of E M Bruce &Co leaving the other advances made to the said firm by the said H. Bruce [Henry Bruce] as per his Book acct. [account] to be hereafter settled by us.

It is also understood that the said H. Bruce [Henry Bruce] afsurnes [?] to pay Our Acceptance of J. D. McGills Draft dated Nov 10/55 [November 10, 1855] and negotiated for our benefit at Br Nothern [Northern] Bk at Covington for \$2.500 at 90 days. And a balance [balance] of about \$178. to L F Potters for Iron. And also our cost and attys [attorneys] fees. in the suit against Fowler & Ludlow for about \$41.

This leaves us the joint owners of one third of the property Real & personal. now belonging to and in the pofsefsion [possession] of E. M. Bruce &Co [Eli M. Bruce] each having paid one half the present cost of same We are to share equally in the profits or loss thereof (Signed in Duplicate.) H Bruce [Henry Bruce] [his signature]
