I. <u>CALL TO ORDER</u>: This special meeting of Faculty Senate was called in anticipation of the HERC meeting to be held December 15th with the possibility of an additional meeting on the 20th. Senate President Firak will be in attendance at both of these meetings.

II. University President Leon Boothe addressed the Faculty Senate and guests about the pending outcome. His comments then should not be taken as unequivocal. A few highlights from his address:

A. He felt that the process was not correct and had not been collegial.

- B. Performance funding appeared a national trend, i.e., clearly funding is going to be determined by outcome--students retained, competency scores, etc.
- C. Degree programs will be eliminated. All institutions have been asked to do so.
- D. As concerns Chase Law, the Governor stated, "All things are on the table."
- E. Northern plans on consolidating 6 and eliminating 6 programs. The process would seem to indicate the consolidation or elimination of 153 programs.
- F. CHE will implement all consolidation and elimination of degree programs.
- G. Despite overall tone and character of process President Boothe is optimistic.

H. Timetable for implementation seems to be Fall of '94 with a commitment

to permit students presently in marked programs to finish their degrees. III. Senate President Firak asked the assembled Senators whether they wished to have the scheduled December meeting or not. The consensus was to cancel the meeting.
