II. Labor and Industrial Relations Program Proposal

Bob Miller, Chair, Public Administration, was present to field questions by the Senate. Several Senators had questions and Lou Noyd pointed out a possible duplication of efforts concerning LAS 300, Introduction to Collective Bargaining, which is also offered in the Business Program. Dr. Miller cited a difference in focus and perspective between the two courses. Byron Renz moved to accept the proposal. Frank Steely seconded the motion. Gary Johnston introduced two proxy votes which were in turn accepted by the Executive Committee for inclusion in the final vote count. These were from senators Joseph Ohren and Mildred Clark. The proposal was accepted unanimously.

III. The Human Service Program Proposal

The Human Service Proposal was removed from the agenda because of the failure of said proposal to clear the University Curriculum Committee. Discussion developed as to the propriety of discussing a motion in the Full Senate that had failed in committee. The consensus reached was that it was not proper.

Bob Miller expressed gratitude that faculty committees have taken so much extra time to consider these pending proposals.
