## C. AIR QUALITY REPORT: (Dennis Lye, ad hoc committee chair, responded to inquiries.)

1. In light of what appeared to have been a rather dismal and pointless exercise, the ad hoc Air Quality made its report to Senate. The report appeared to convey an air--as t'were--of frustration with the ability of any group to ascertain as to whether or not a problem existed to be discovered; a reluctance--expressed by the committee chair--as to whether the individuals saying there were problems were actually able to "prove" such [when questioned closely Lye stated directly that his opinion was that the problem was really nothing more than the complaints of one person]; and a reluctance on the part of administrative side of the house to see that there was any sort of problem at all and a firm claim that all was running at the best levels of operation possible. (Nifty turn of phrase, that!) Since this was a report which was to have no consequences and given little attention, there seemed to have been much discussion and many questions.

The Department of Music has voted to change the designation of terminal degrees for music as listed in the Faculty Policies and Procedures Handbook, Section XIII, p. 110. We would change M.M. or M.F.A. to Doctorate or M.M.

The doctorate is the recognized terminal degree for music, and the listing of M.M. allows for the possibility of an artist-performer who may have substantial performance experience in lieu of a doctorate. The M.F.A. degree is no longer a common credential in the field of music.

### REPORT BY THE AIR QUALITY/ENVIRONMENTAL ISSUES COMMITTEE

### AD HOC COMMITTEE OF FACULTY SENATE

#### March 3, 1997

The Air Quality/Environmental Issues Committee was formed as an Ad Hoc Committee of Faculty Senate to address the issue of air quality in the University's buildings, both on the Highland Heights and Covington campuses. The committee met throughout the past year, with the membership representing the buildings on both campuses. Discussion centered around the following topics:

- 1) Is there a problem with the air quality in the University's buildings?
- 2) If so, what is the nature of the problem?
- 3) What specific recommendations could be made by the committee?

The committee members met with Bob Bolce and other representatives of building maintenance to view the remote monitoring room housed in the Physical Plant. The committee was informed that the buildings had various ventilation systems, with some of the older systems having more limitations than the newer systems. The committee questioned whether the ventilation systems of the buildings were operating at peak efficiency according to each system's specifications and were assured that this was the case. Physical plant personnel indicated their willingness to address individual problems as they arose (eg, warm temperature on a particular floor of a building). They indicated that they would like to purchase portable monitoring units that could be used for "spot-checks" in the buildings; however, the cost of the units was prohibitive. An "Indoor Air Quality - Request for Investigation" form was developed to document the occurrence of problems relating to air quality in the buildings.

The report, "Faculty, Staff, and Student Beliefs About the Relationship between Health-Related Symptoms and Building Conditions" submitted by Joan Ferrante (February 6, 1996) addresses the questions (1) Does a real problem exist? (2) If so, what is the nature of the problem? The findings of this report, based on the responses of 1146¹ faculty, students, and staff indicate that at the very minimum, a significant percentage believe there is some connection between their physical symptoms and the condition of a building(s) on campus. Among those who responded:

- 991 (or 86.5%) checked one or more of the 11 symptoms listed as something they had experienced in the past week.
- Of those, 169 (or 17.5%) believe that their symptoms are connected in some way to a building (147 of the 169 offered a written explanation). Another 27.3 percent are not sure if there is a connection. 44.8 percent see no connection at all between their symptoms and the buildings.

Table 1 shows the number of full- and part-time faculty, staff, and students with symptoms and the percentage of those with symptoms who believe there is no connection along with the percentage who believe there is a connection. It also shows the percentage who are

unsure as to whether there is a connection.

Other significant findings are:

- 1 in 5 respondents (20%) have had a conversation with another person on the subject of physical symptoms and buildings.
- The buildings named as potential problems in these conversations were Landrum Hall (86 times), Natural Sciences (47), Nunn Hall (31), Albright Health Center (29), BEP (29), Fine Arts (29), and Science & Technology (10).
- Among respondents who spend at least 2/3 of their time in one building on campus, the respondents from Landrum are least likely to be symptom-free (only 5 percent checked no symptoms) followed by respondents from the Fine Arts building (8 percent symptom-free). The most symptom-free respondents were from Science & Technology with 29% symptom-free.

Since NKU is not immune to experiencing air quality problems within the buildings on both the Highland Heights and Covington campuses, the committee would like to make the following recommendations, which are ranked in order of priority:

posses

Contract with an independent, outside agency to evaluate the ventilation systems and ducts to determine whether they need to be cleaned. If a positive determination is made, the committee recommends that the air ducts and ventilation systems of the buildings receive the necessary cleaning.

passes

Make the NKU community aware of the existence of the "Indoor Air Quality - Request for Investigation" forms (eg, announcement in *The Northerner* and *Campus Digest*) and disseminate them to all of the departments on campus.

PUSSES

Reallocate funds or increase the maintenance line in the University's budget so that the ventilation systems can be properly maintained and monitoring equipment purchased as needed.

PEISS 41

Recommend that, within the next two years, the Administration take advantage of the Health Hazard Evaluation performed by NIOSH to address the problems of maintenance of the ventilation systems.

bezze

Request that the Administration of the University formally report back to the Faculty Senate with regard to the status of maintenance and the efficiency of the ventilation systems in the buildings after a MOSH evaluation is performed.

Proposed Constitutional Amendment to Article VIII. Meetings, Section G.

# Existing Language:

Agenda items and supporting information shall be submitted to the Executive Committee at least fourteen calender days prior to the scheduled Senate meeting. Items may also be placed on the agenda by the Executive Committee on its own motion of any member of the Senate, or by petition signed by at least ten members of the general faculty at least seven calendar days in advance of the Faculty Senate meetings.

# Proposed Language;

Agenda items and supporting information shall be submitted to the Executive Committee at least fourteen days prior to the scheduled Senate meeting. Items may also be placed on the agenda by the Executive Committee, or by petition signed by at least ten members of the general faculty at least seven days in advance of the Faculty Senate Meetings. Items may be added to the agenda on the day of a senate meeting by a two-thirds vote of those senators present and voting.

Rationale: Current senate practice violates our Constitution. The proposed amendment will align senate practice with the Constitution.
