SYNOPSIS: Staff Congress Meeting of November 12, 1987.....

Replacement on Staff Congress include the following: Marilyn Reis, in the Physical Plant category replaces Durant Mathis; Phil Webb, Physical Plant, replaces Sonda Cummins in the At-Large category; Mary Wilson, Computer Services, replaces Mitch Mullins in the Administrative Affairs category.....Janet Krebs has been appointed as staff representative on the committee to hire a paid consultant.....Kathy Qualls has agreed to continue her position on the University Non-resident Fees Committee.....Vice President Diane Hunley reported on the Board of Regents meeting of October 10, 1987. Grants & Contracts activity for the period of July 1, 1987 to September 30, 1987 has had funds approved of \$1,213,455, an increase of 15% for the same period as last year. Campus planning reported the Applied Science and Technology Center design work has been completed and bids began October 30, 1987. Ground breaking ceremony is being planned. Work is continuing on the Landrum Building drainage problems. New metal roofing has been installed on UC, LA, NS and Main Library buildings. Work is continuing on FA and the work is expected to be completed in early November. New fire alarms were installed in Nunn Hall, Fine Arts and Steely Library. Baseball field dugouts have been completed. Professional Liability Insurance, a five million dollar policy from United Educations Insurance Risk Retention Group, Inc. through Marsh & McLennan, Inc. in Louisville, KY. This policy covers Regents, Directors, Officers, Administrators, Faculty, Staff, volunteer workers and student teachers, discrimination, breach of contract and tenure review. The policy is in effect September 29, 1987 through September 28, 1988. In the period July 1, 1987 through September 20, 1987 in the academic and non-academic personnel there have been 44 new staff members, 31 leaving the university, 16 transfers, promotions, reassignments or title changes.....Don McKenzie announced that he and LaVerne Mulligan would be attending a State Staff Congress meeting in Louisville, Sunday, November 15, 1987. This is the first meeting of this kind and included members of Staff Congress from NKU, Morehead State University, Murray University and the University of Louisville. They hope to gain support of all eight universities in Kentucky.

Dental rates effective January 1, 1988 up 13% from \$6.22 in 1987 to \$7.08 in 1988.....The Social Security taxable wage base for 1988 will be \$45,000. It is \$43,800 in 1987. The Social Security tax rate will be increased for both NKU and employees to 7.51% The increase will bring the maximum Social Security tax in 1988 to \$3,379.50, an increase of \$247.80 over the current maximum of \$3,131.70.
