FACULTY SENATE MEETING JANUARY 27, 2003

The meeting was called to order at 3pm. President Weiss announced two changes to the agenda. The Justice Studies 101 curriculum item has been removed since it was tabled at the UCC meeting. President Votruba will not be at the meeting today due to the death of his mother-in-law. The Provost is in Frankfort.

The 2003-04 Senate met just before this meeting to elect officers. President Weiss announced that those officers are: Chair, Benefits Committee: David Hogan; Chair, Budget Committee: Dennis Lye; Chair, UCC: Ron Shaw; Chair, Professional Concerns: Phil McCartney; Parliamentarian: Ed Brewer; Vice-President: Carol Bredemeyer; President: Steve Weiss.

The minutes of the December 11, 2002 meeting were approved.

Carole Beere, Associate Provost for Graduate Studies and Outreach, gave a presentation on the University's distance learning efforts, focusing on total web based programs. She said that her goal was to let the Senate know what we're doing and the direction we are taking and to gather input. NKU's distance learning efforts support two Council on Postsecondary Education goals: 1) Enroll more students in college, and 2) Ensure that students advance through the higher education system.

There is a Steering Committee for distance learning whose members are: Craig Agneberg, Arne Almquist, Bob Johnson (from KCTCS), Nancy Lang, Dixie Leather, Charles Pinder, Debbie Poweleit, Jeff Smith, Jerry Smith, and Chris Stiegler. Pat Moynahan and Carole Beere are co-chairs.

OFFICER REPORTS

President: President Weiss announced that after consulting with the Executive Committee that he would allot time during his report to Student Government, rather than amend the Senate constitution. Burhan Mohamedali, Vice President for Student and Academic Affairs, spoke about a February 1 meeting with legislators on campus. There will be a media conference at 9:15 in the UC TV Lounge and a 10am Caucus meeting in the cafeteria. In concert with student body presidents from the other state universities, e-mail, letters, and resolutions will be used to contact legislators and urge them not to cut funds for higher education. On February 27, students will hold a rally in Frankfort and faculty were urged not to schedule tests that day.

President Weiss announced that the Provost has decided to put the campus conversations about realignment of colleges on hold due to the budget situation.

Vice President: No report.

<u>Secretary</u>: Carol reported that COSFL had participated in interviews with the final candidates for CPE President. Tom Layzell has been hired – he currently holds a similar position in Mississippi. He has already indicated an interest in meeting and working with COSFL.

She also urged faculty not to use NKU e-mail accounts to contact legislators with comments about the budget situation. NKU accounts should not be used for lobbying, a violation of the campus e-mail policy.

COMMITTEE REPORTS

Professional Concerns (Phil McCartney): The next meeting will be February 6.

<u>Curriculum</u> (Ron Shaw): Voting item – Recertification of General Education courses. In response to a question, he noted which requirement the courses satisfied:

ANT 100 – Behavioral Science ANT 230, 231, 245 – Non-Western ED 291W – Written Communication II WMS 150, 310 – Race & Gender

A motion to amend to approve each course separately FAILED with two abstentions. The main motion to approve all the courses PASSED with two abstentions.

<u>Benefits</u> (Diane Gronefeld): The committee is considering provision of benefits for domestic partners. A subcommittee is currently gathering information and working on a definition of domestic partner.

Budget (Terry Pence for Dennis Lye): The next meeting is February 4.

There was no New Business and there were no announcements.

The meeting adjourned at 4:11pm.
