- I. The meeting was called to order at 3:05 p.m. in University Cafe A/B/C.
- II. The minutes of the August 31, 1992 were amended to note that Rosetta Mauldin and Michael Avey were in attendance at the August meeting. Minutes were approved as amended.
- III. There were no additions or deletions to the agenda.
- IV. Senate President's Report:
 - A. As yet the Faculty Benefits and University Curriculum Committees have no Chairs. In this growing saga of indifference and/or battle fatigue two important committee continue to go without Chairs. Having met with the committees the Senate President offered some possible resolutions:
 - 1. Faculty Benefits paper works will be handled by the Senate office. All that will then be required will be person to preside at the meetings.
 - 2. U.C.C. will handle only rules, general studies changes, program changes. Only these matters will be brought to the Faculty Senate for consideration and a vote. Individual College Subcommittees will handle other, routine matters and report these to the U.C.C. as a matter of record. These shall not be voting items before the U.C.C. or the Senate. There was understandable concern, if not alarm, expressed over such decentralization. No one, however, was moved to volunteer for the vital position. And the ignominy of the situation was further compounded when the Provost assented to a request that a person in such a situation be paid, stating that funds might be found considering The importance and urgency of the situation. O, Temporal O, Mores! No doubt these proposals warrant and shall receive considerable discussion. Remember, however, pietra mossa na muschis. Let us not be mossbacks. Faced with a minor crisis, the Senate so empowered the Senate President to resolve the matter of chairs for both committees for the moment and then in consultation with the Provost come up with a long range answer, with special regard to the Curriculum process.
 - 3. Proposed revisions of the Early Retirement Plan: The incentive plan to be presented for our consideration will include such features:
 - a. meeting the rule of 70
 - b. applicant must be at least 60
 - c. no more than 80% vested in retirement
 - d. proposal will run through the year 2000 A.D.

- 2. Veteran's Day will be observed Nov. 11 here on campus. All are encouraged to attend as their schedules permit. The ceremony will especially honor veterans here on campus.
- 3. Margo Ferrante addressed the Senate concerning the activities on Health Issues Day. Be aware! Get Involved! Read the Digest for all the nitty, gritty details.
- V. Committee Reports
 - A. Faculty Benefits: committee met and sub-committees were appointed. The continued good news from this arena was Gov. Brereton's health plan which would appear to be a disaster plan for anyone wanting genuine health coverage. This plan would drastically cut and reduce the kind and amount of coverage we presently receive. Read your newspaper. Write your congress representative!
 - B. Budget: No report.
 - C. **Professional Concerns**: Environmental Concerns Sub-committee reconvened with Ted Weiss as chair. An ad hoc committee is looking into a smoking/non-smoking policy and designating certain areas as smoke free.
 - D. Curriculum: Issues currently before the committee:
 - 1. Integrative Studies Proposal
 - 2. Upper Division Studies Concentration
 - 3. Guidelines on the nature of Intersession course offerings.
