- I. Call to order The meeting was called to order at 1:17 p.m. with a quorum present.
- II. Minutes of the May 13, 1993 meeting were approved.
- III. President's Report Linda Wright welcomed the new Staff Congress members, and acknowledged each of the out-going members, re-elected members, and continuing members.
- IV. President Elect's Report Chuck Pettit. No report.
- V. Standing Committee Reports.

 Benefits Cheryl Torline. No report.

 Constitution and Bylaws Elaine Shafer. No report.

 Credentials and Elections Ruth Enzweiler. The committee successfully conducted the SC election by mail ballot.

 Liaison Gayle Vaughn. Encouraged members to submit news to Diana Schneider.

 Policies Allen Bloomhuff reported that they are waiting for updates on the Family Leave policy and the NKU leave policy.

<u>Salary and Budget</u> - Sue Roth. The committee is still waiting on a response from the Budget Office regarding the amount of health utilization savings. Linda Wright suggested that committees be more formal in future and make formal requests in writing.

VI. Ad Hoc Committee Reports.

<u>Food Service Advisory</u> - Sandy Flora. Contacted Ken Ramey about shortened hours and limited offerings.

Health Utilization - Cheryl Torline. The committee will meet June 15, and discuss re-bidding the health insurance contract.

Naming of Facilities and Endowments - Janet Krebs. No report.

Parking and Traffic Control - Gail Jewell. No report. Linda Wright reported that there will be new regulations in the fall, and the committee was bypassed; the new regulations include 'pull in' parking, and some fines were made non-appealable (e.g. expired parking meter).

Scholarship Committee - Donna Gosney. No report. Chair Glenn Strausbaugh suggested limiting number of years that a recipient can win. Linda Wright initiated setting up a short-term ad hoc committee to investigate and make recommendations. She thanked the scholarship committee for the hard work that

it did.

Smoking Policy Committee - Claire Newman. No committee report. Dennis Taulbee has a final draft of the smoking policy, which has been presented to Dr. Booth for his approval.

<u>Titling</u> - Chuck Pettit. The committee has presented a draft to Personnel Services and also submitted a time-table.

- VIII New Business The possibility of employees receiving their paychecks early (if they are off on payday) was raised. If payroll deduction is not available, Margo Ferrante will deal with such situations on an individual basis. Linda Wright noted that media coverage of the proposed Faculty/Staff/Alumni center still refers to it as the Faculty/Alumni center, excluding staff; this is not acceptable and we will continue to push for staff inclusion. Virginia Stallings presented a slate of candidates for the Executive Council; the current officers have agreed to run again: Linda Wright for President, Chuck Pettit for President-Elect, and Jay Stevens for Secretary; other nominations can be made from the floor at the next Staff Congress meeting in July.
