CREDIT UNION

The Credit Union has lowered interest rates on selected loan types and continues to pay 8 percent on all share accounts totaling \$1,000 or more and 6 percent on deposits less than \$1,000. At the most recent board meeting, the dividend structure above was declared for the quarter ending September 30, 1986.

At the previous board meeting, interest rates were lowered on collateralized loans, and the maximum loan amount was increased to \$20,000. The loan rate on a new car is now 10 percent of the purchase price. Loans for used cars can be secured at 12 percent when borrowing up to 80 percent of the purchase price. Borrowers can now receive approval on a car loan and a check the same day. Remember the Credit Union interest rate includes the cost of life and permanent disability insurance and interest is only paid on the remaining balance.

In other actions the rate for share secured loans was reduced to 2 percent above the declared dividend rate, but not below 10 percent on any loans. Also, borrowers now receive same day turnaround on these loans. The board eliminated the 90-day loan waiting period for new members.
