3) Budget Committee - Andrea Gauthier



MEMOR ANDUM

January 27, 1986

To: Lynn Langmeyer

Re: Dr. Martin Luther King, Jr. Holiday

In acknowledging the receipt of the memo of January 22, 1986 bringing to my attention the Senate resolution for an institutional holiday for recognizing the achievements of Dr. Martin Luther King, Jr., I was not aware that this was being contemplated by the Senate. Also, I am not aware as to whether there was any consultation with the administration before passage of this resolution. Furthermore, I assume that the Senate surveyed the faculty and the department chairs before adopting this resolution, since it does require as the resolution indicates an additional "no classes Monday".

I regret to inform you that I cannot support this resolution due to the fact that this University already has a full complement of holidays for an institution of higher education in this state. As you are aware, the Commonwealth of Kentucky does not recognize Dr. King's birthday as an official holiday. As a state institution, we are guided very much by state-supported holidays.

I should indicate to you that there have been extensive discussions by my staff regarding this topic. Because I have many reasons for basic sympathy with the intent of your memo, I would entertain an offer on behalf of two representatives from the Faculty Senate in concert with two representatives from the Staff Congress and my administrative designees to meet and review this issue. If the Faculty Senate, the Staff Congress and the administration can agree on deleting one of the current holidays and replacing it with the proposed Dr. King holiday, I would be most happy to seriously consider such a recommendation.
