Orientation started with a luncheon at noon. At 1:00 pm NKU Administrators spoke with the group and answered questions. Dr. Boothe spoke about reorganizing of the University. Sheila Bell from Legal Counsel spoke of her responsibilities of her office. Carla Chance reminded us that the Staff Awards Luncheon will be held in Regents Hall on October 6th. This week is Open Forum on Health Care Alliance. Please plan to attend any of the remainder meetings. More information can be obtained from the vendors involved and staff questions answered on Health Issues Day, in the Albright Health Center on October 11th. Administration has met some of the proposed policies of Staff Congress such as personal time, and will be working on Flex Time and others in the near future. She also talked about funding for a new science building. A question on funding of the proposed entrance park and bell tower came up.
