A) The committee reconsidered its recommendation regarding faculty advising. The committee reaffirmed its committment to reduce the number of faculty present at walk-in registration.

## 5. Handbook Revision - Fred Schneider, Chair

The committee met and found several "glitches" in the handbook. The Provost Office is fixing these problems. The committee is being expanded as Linda Olasov has requested representation from the Provost and the President. The task for the Spring Semester is to review the procedure regarding promotion, tenure, ran and to expand these to include library personnel too. The process of handbook revision will extend into the next academic year.
