2.4 BVALUATION

The criteria and procedures set forth in this Article apply to reappointment [See Article 2.5], to promotion [See Article 2.6], and to tenure [See Article 2.7]. The criteria set forth in this Article also apply to performance review [See Article 2.9].

2.4.1 CRITERIA

In making the evaluations required for reappointment, promotion, tenure, and performance review decisions, three criteria are to be used: TEACHING RFFECTIVENESS, SCHOLARLY AND CREATIVE ACTIVITY, and INSTITUTIONAL AND PUBLIC SERVICE. Departments or Colleges may add additional criteria, but may not delete any of these criteria. If a Department or a College proposes additional criteria, the additional criteria shall be treated as an amendment to this Handbook for that Department or College and must be approved through the normal amendment process before becoming effective. Such additional criteria must be promptly distributed to every member of the Department or College and must thereafter be applied to all appropriate decisions.

2.4.1.1 TEACHING EFFECTIVENESS

Evidence of teaching effectiveness may include, but is not limited to, the following:

A. An evaluation of course syllabi, including systematic organization of appropriate materials for presentation and communication to students of course objectives, plan of study, and means of student performance evaluation;

B. An evaluation of the effectiveness of presentation, whether by lecture, discussion, recitation, demonstration, laboratory exercise, practical experience, consultation, field trips, computer-assisted instruction, or other instruction methods.

C. An evaluation of assessment procedures, such as test,

grading practices, and student performance.

D. An evaluation of professional responsibility, such as meeting classes timely, returning materials in a timely fashion, supervising students; advising students; treating students in a fair and impartial manner;

E. An evaluation of the effectiveness with which students are stimulated to develop critical and creative abilities and intellectual curiosity by such means as independent study,

research projects, or student performances.

F. An evaluation of textbooks, workbooks, manuals, tapes, slides, other print and nonprint learning resources developed primarily for one's own classroom use.

2.4.1.2 SCHOLARLY AND CREATIVE ACTIVITY

Rvidence of creative and scholarly activity may include, but is not limited to, the following:

A. Publication of books, monographs, articles, maps,

A. Publication of books, monographs, articles, maps, bibliographies, indexes, catalogs, textbooks, and papers in professional journals; production or direction of non-print media work; reports to federal, state or local agencies; cases;

B. Production and display of musical compositions,

B. Production and display of musical compositions, paintings, sculpture, ceramics, weaving, photographs, graphics and other works of art; recitals, choreography, stage design and

construction, costuming, direction; production of film and video taped materials;

C. Presentations of papers, cases, media productions, etc., at professional and other scholarly meetings; discussant and panelist in scholarly meetings and juried shows;

D. Editing and reviewing of books, articles and monographs

for publication in scholarly journals;

B. Participation in studies, programs, and creative activity supported by extramural funds; attendance at professional meetings and leadership in professional meetings;
F. Inventorship or co-inventorship leading to U.S. or other

patents, or both;

G. Development of experimental programs, of innovative curricular materials such as curriculum guides, computer assisted instruction, lab equipment, video tapes, films and film strips, manuals, workbooks, tools, or models which break new ground and successfully advance concepts, ideas and approaches that transcend ordinary instructional material;

II. Invitations to conduct research, lecture or display works at other universities or research oriented agencies; to prepare

questions for professional examinations;

I. Continued progress in current research or creativity not yet resulting in publication, presentation, performance, or display.

2.4.1.3 INSTITUTIONAL AND PUBLIC SERVICE

Evidence of institutional and public service may include,

but is not limited to, the following:

A. Service on departmental, college or university committees, councils, senates; to local, state or national governmental boards, agencies, commissions; to business and industry or private citizens as technical expert or member of a policy advisory committee; as organizer/director of seminars, workships or other conferences;

B. Participation in meetings, symposia, conferences, workshops; in radio, television by developing and presenting materials for public awareness; conducting or performing;

- C. Work with schools through contact with teachers, administrators, students; through participation in events such as science fairs, college day programs, lectures, performance, inservice programs; through advice on curricular matters,
- D. Direction of interships, cooperative education, practical; learning laboratories, professional clubs and other organizations:

B. Advising student organizations, and facilitating student

events and activities;

F. Writing of grants for instruction, research, and administrative support activities.
