# Staff Congress Records RG-045

#### **ABSTRACT**

Northern Kentucky University Staff Congress Records (1980-2009) consist of founding and governance records, including the constitution, bylaws and resolutions; meeting agendas, minutes and supporting materials; committee records, including standing, ad-hoc and university committees; publications; programs and projects documents; university funding records and administrative files.

### ADMINISTRATIVE/BIOGRAPHICAL HISTORY

Staff Congress is the official representative governing body of all Northern Kentucky University staff employees, organized and operating under its own constitution and bylaws.

The purpose of Staff Congress is to "create a stronger bond within the staff, solicit and express the opinions, suggestions, and recommendations of the staff on all matters of concern to the various staff constituencies and to the staff as a whole. The Staff Congress shall continually review all University policies and documents affecting staff affairs and welfare and make recommendations concerning these matters to the Vice President-Administration and Finance and to the Director of Human Resources. Likewise, the Staff Congress shall seek representation in all aspects of Northern Kentucky University governance."

The formation of Staff Congress began in April 1981 when the Board of Regents approved President A. D. Albright's recommendation "that the administration be authorized to facilitate changes in the existing governance structure of the University to include a Staff Council and a University Council as a result of recommendations made by outside consultants, the Faculty Senate, and Student Government".<sup>2</sup>

With a brief outline for the organization, structure, and representatives' eligibility, the first elections were organized and held on December 1, 1981.<sup>3</sup> On March 9, 1982, the Board of Regents officially approved the Staff Congress Constitution and Staff Congress was formally established. Staff Congress remains an active organization.

#### Representation

Staff Congress representatives are elected annually and they serve overlapping, staggered, two year terms. All eligible staff employees may vote in the Staff Congress elections. The total number of Staff Congress representatives shall not exceed thirty-five, with four at-large representatives and a proportional number of representatives from each division, not to exceed thirty. Officers include a President, a President-elect and a Secretary/Treasurer. Staff Congress representatives elect the President-elect and Secretary/Treasurer annually. The Staff Congress President appoints a Staff Congress Parliamentarian annually.

### Meetings

Staff Congress holds regular monthly meetings. All meetings last no longer than two hours and are open to the public.

#### Committees

Staff Congress representatives serve on standing, ad-hoc and university committees. All Staff Congress representatives, as established by the Bylaws, are required to serve on at least one standing committee. The Staff Congress Executive Council annually appoints representatives to the standing committees. The President, in consultation with the Executive Council, may appoint representatives to the ad-hoc and university-wide committees. Committee chairs and university committee representatives submit and present monthly reports when merited.

## **SCOPE AND CONTENT**

The records of Staff Congress consist of materials accumulated from its creation by the Board of Regents in 1981 through 2009. This is an open record group and new additions to the collection are expected to occur. These records include founding documents, constitution, bylaws and resolutions; membership lists; meeting schedules, agendas, minutes and supporting materials; committee minutes, reports and correspondence; newsletters; programs and projects documents; areas of concern/open forums documents, surveys, speech transcript, university funding documents and administrative files.

The collection has five series: Governance Records, Meeting Records, Committee Records, Publications and Other.

**Series I, Governance Records (1981-2003),** contains records concerning the establishment and governance of Staff Congress. These materials include establishing correspondence and research, the original and revised versions of the constitution and bylaws, and resolutions.

**Series II, Meeting Records (1982-2004),** contains agendas, minutes and supporting materials for the Staff Congress meetings. The majority of these records came from the official binders maintained by Staff Congress Presidents and Secretaries/Treasurers that they turned in at the end of their terms. Some agendas and/or minutes are missing, particularly in 2003-2004. In addition, supporting materials are not available for all meetings.

**Series III, Committee Records (1981-2006),** contains brief descriptions of standing and university committee functions along with the records of the executive, chairs, standing, ad hoc and university committees. These records include agendas, minutes, reports and correspondence.

**Series IV, Publications (1982-2002, 2007-2009),** contains Staff Congress newsletters and brochures. All staff received the newsletter through campus mail. The newsletter content included Staff Congress meeting actions and brief reports, campus news, and staff work accomplishments and personal life events. The newsletters contain a gap from April 2002-December 2006. The only brochure dates from 2004.

Series V, Other (1981-2003), contains a variety of records. The programs and projects records include Staff Awards Day Luncheon, 1985-1987, and Staff Congress Orientation, 1990-1991, 2002-2003. The areas of concern/open forums, 1997-2002, records were a result of an effort to create a more direct line of communication with the administration on issues of staff concern. This series also includes two surveys. The first, taken in 1988, is a Review of Staff Congress and the records include a copy of the survey and tabulated results. The second, conducted in 2000, is an in-depth Northern Kentucky University Staff Satisfaction survey designed to study the overall quality of staff work life at Northern Kentucky University. This series also includes a speech by the Staff Congress President given during Dr. Leon Boothe's installation as university president in 1983. The university funding records focus primarily on staff position funding and cuts during 1983-1991. The administrative files include constituency lists, 1984; correspondence, 1981-2001; and Staff Congress representatives' letters of resignation, 1984-2002.

#### SYSTEM OF ARRANGEMENT

The Staff Congress records are arranged in five series: I. Governance Records, II. Meeting Records, III. Committee Records, IV. Publications and V. Other. The contents are arranged as follows: Series I is hierarchical; Series II and IV are chronological; Series III is hierarchical by committee type; Series V is alphabetical with the exception of the administrative files.
